NNSA proposes to use this field to provide an improved link between facilities budgets and the <u>predominant</u> Program Office that uses the facility. To make this linkage NNSA proposes the following office designations be valid inputs:

NA-10 - Defense Programs (DP)

NA-20 - Defense Nuclear Nonproliferation (NN)

NA-30 - Naval Reactors (NR)

NA-40 - Emergency Operations (EO) NA-60 - Office of the Administrator (NA)

NA-70 - Defense Nuclear Security (DNS)

Department of Homeland Security (DHS)

Department of Defense (DOD) Other Federal Office (OFO)

Ideally, we would like these as a "pick list" to include "other" and "not applicable" as allowable choices. Some NNSA Offices have not been identified as they are unlikely to be the predominate program of record using a facilities. For example, NA-50 is not included.

NNSA would urge other DOE Offices to develop and adopt a similar categorization for their Program Offices such that the information is tracked consistently across DOE. At a minimum, if other DOE offices do not adopt a similar structure, NNSA would also like DOE Office level Information available as valid picks to assist NNSA sites linking the mission dependency of facilities to other DOE programs that are on NNSA sites. The minimum valid inputs would be:
