11/21/07 - The committee agreed that the building usage code is not the appropriate field to capture the nuances of these types of facilities as that would not trigger any differences in DM or FCI calculations. Some other sites are currently identifying these facilities as "shutdown pending D&D," which removes the building from the site's FCI calculation, but incorrectly portrays the operating status as training staff still use these buildings. Also, Gary Horn discussed the ties between optimal year and FCI with respect to this request. The committee tabled further discussion of this RFC pending Gary's follow-up with his colleagues. 1/16/08 - The Committee tabled further discussion pending further follow-up from OECM. 5/21/08 - FAC Not Approved. The Committee concurs with the OECM recommendation to use a change in status to "Shutdown Pending D&D" to properly capture the interim use of such facilities. FAC does not recommend a new usage code (which would not have an impact on the FCI/maintenance requirements). FAC also notes that such facilities should not be categorized as "Mission Critical."
