FIMS WOULD PRODUCE THE EXCLUDED BUILDINGS LIST REPORT FOR THE SITES AND FOR DOE COLLECTIVELY BASED ON INFORMATION WITHIN FIMS.		
THIS REQUEST WOULD APPLY TO BUILDING AND TRAILER. THIS MAY APPLY TO OSF AS WELL BUT THAT DETAIL HAS NOT YET BEEN DETERMINED.		
JUSTIFICATION:		
ENERGY LEGISLATION AND DOE ORDER 430.2B ALLOW SITES TO EXCLUDE CERTAIN BUILDINGS FROM THE CALCULATION OF ENERGY INTERSITY. (ENERGY INTENSITY IS ENERGY USAGE DIVIDED BY SQUARE FOOTAGE.) THE LEGISLATION ESTABLISHS REDUCTION GOALS IN ENERGY INTENSITY FOR EACH FISCAL YEAR. THE EXCLUDED BUILDINGS LIST REPORT SHOWS PERTAINENT INFORMATION ABOUT EACH BUILDINGS THAT THE SITES IDENTIFIES FOR EXCLUSION. ALL OF THE PERTAINENT DATA RESIDES IN FIMS WITH THE EXCEPTION OF THE EXCLUSION TYPE AND THE JUSTIFICATION FOR THE EXCLUSION. DURING THE PAST TWO YEARS THE EXCLUDED BUILDINGS LIST REPORT HAS BEEN GENERATED OUTSIDE OF FIMS, BUT BASED ON FIMS DATA, AND SUBMITTED VIA THE SITE OFFICE AND PROGRAM OFFICE TO FEMP. IN THEORY, ALL THE BUILDINGS ON THE EXCLUDED BUILDINGS REPORT ARE THE SAME SET OF BUILDINGS IN FIMS WITH SQUARE FOOTAGE DATA REPORTED IN THE "ENERGY CONSUMING METERED PROCESS (EXEMPT) FACILITIES" FIELD. OFTEN THERE IS A MIS-MATCH BETWEEN THE TWO WHICH NEEDS TO BE RECONCILED.		
IF THESE PROPOSED CHANGES ARE ACCEPTED, THEN FIMS BECOMES THE ACCEPTED SOURCE OF INFORMATION ABOUT EXCLUDED BUILDINGS RATHER THAT THE OFF-LINE PROCESS THAT HAS BEEN USED IN THE PAST. SINCE THE EXCLUDED BUILDINGS: IST REPORT IS REVIEWED AND APPROVED AT THE SITE OFFICE AND PROGRAM OFFICE LEVEL, GREATER ATTENTION WILL BE PAID TO THE

THE LOCKOUT ENSURES THAT THE SAME IDENTICAL REPORT WILL BE GENERATED ANY TIME DURING THAT 90 DAYS PERIOD.

LAST YEAR (FY07) THERE WERE ABOUT 1275 BUILDINGS ON THE EXCLUDED BUILDINGS LIST REPORT. EACH YEAR SOME BUILDINGS MOVE OFF THE LIST AND SOME NEW ONES ARE ADDED TO THE LIST. WE CAN PROVIDE A SPREADSHEET THAT GIVES THE PROPERTY SEQUENCE NUMBER AND THE INFORMATION FOR THE TWO NEW FIELDS FOR EACH BUILDING THAT WAS ON THE LIST FOR LAST YEAR. THIS WILL HELP POPULATE MOST OF THE FIELDS WHERE DATA IS NEEDED. WE WILL THEN ASK EACH SITE TO REVIEW AND REVISE THE DATA AS NEEDED.
