IN THE FIMS DATA DICTIONARY, FOR THESE FIELDS, MAKE THE FOLLOWING CHANGES:

1. IN THE **ENGLISH NAME** COLUMN, STRIKE "(NEW CONSTRUCTION)"
2. IN THE **DESCRIPTION (DATA SOURCE)** COLUMN, ADD THIS INITIAL PARAGRAPH:

"FOLLOWING SUBSTANTIAL COMPLETION OF A CERTIFICATION APPLICATION, (E.G., LEED) INDICATE THE QUARTER DURING WHICH CERTIFICATION IS ANTICIPATED."

AND

"FOLLOWING SUBSTANTIAL COMPLETION OF A CERTIFICATION APPLICATION, (E.G., LEED) INDICATE THE FISCAL YEAR DURING WHICH CERTIFICATION IS ANTICIPATED."

**JUSTIFICATION:** THE PROCESS TO OBTAIN LEED CERTIFICATION FOR NEW CONSTRUCTION / MAJOR RENOVATIONS BEARS SUFFICIENT SIMILARITY TO EXISTING BUILDING OPERATIONS AND MAINTENANCE THAT THE VALUE THE FIELDS PROVIDE FOR ONE CASE SHOULD EXTEND TO THE OTHER.
