Proposed Change:	<p>Update the title, definition, and pick list for the "National Laboratory" data element to identify assets included in the Manhattan Project National Historical Park (MAPR).</p> <p>Proposed data element name: National Laboratory or National Park</p> <p>Proposed data element definition: Identifies assets that belong or are the responsibility of a DOE national laboratory for the purpose of advancing science and technology to fulfill the DOE mission. Identifies DOE-administered facilities and lands that are included in the Manhattan Project National Historical Park (MAPR) established to preserve, interpret, and facilitate access to key historic resources associated with the Manhattan Project. Choices are:</p> <p>Proposed additional pick list options:</p> <ul style="list-style-type: none"> • MAPR - East Tennessee Technology Park • MAPR - Los Alamos National Laboratory • MAPR - Oak Ridge National Laboratory • MAPR - Richland Operations Office • MAPR - Y-12 National Security Complex <p>Background: The U.S. Department of the Interior (DOI), National Park Service (NPS), <u>Foundation Document: Manhattan Project National Historical Park</u>, January 2017, identifies assets included in the MAPR.</p> <p>The MAPR currently includes DOE-administered facilities and lands identified in the attached list. The NPS and the DOE may in the future include in the MAPR additional DOE-administered facilities and lands consistent with Public Law No. 113-291. If Congress makes additional properties eligible to be included in the MAPR, the NPS and DOE will evaluate these properties for inclusion. According to the DOI-DOE Memorandum of Agreement (MOA) governing MAPR operations, the NPS and DOE will review all eligible DOE-administered properties for potential inclusion in the MAPR every 5 years as part of the MOA renewal.</p>				
Justification:	<p>Each year, the DOE reports deferred maintenance & repair (DM) accrued on real property assets. The report format is governed by the Federal Accounting Standards Advisory Board (FASAB) Statement of Federal Financial Accounting Standards (SFFAS) 42, <i>Deferred Maintenance and Repairs</i> and includes separate subtotals for heritage assets and stewardship land.</p> <p>According to SFFAS 29, <i>Heritage Assets and Stewardship Land</i>, heritage assets are -</p> <p style="padding-left: 40px;">Property, plant and equipment (PP&E) that are unique for one or more of the following reasons:</p> <ul style="list-style-type: none"> • historical or natural significance, • cultural, educational, or artistic (e.g., aesthetic) importance; or

	<ul style="list-style-type: none"> • significant architectural characteristics. <p>Heritage assets consist of (1) collection type heritage assets, such as objects gathered and maintained for exhibition, for example, museum collections, art collections, and library collections; and (2) non-collection-type heritage assets, such as parks, memorials, monuments, and buildings. Heritage assets are generally expected to be preserved indefinitely.</p> <p>One example of evidence that a particular asset is heritage in nature is that it is listed on the National Register of Historic Places.</p> <p>Currently, only DM for DOE assets identified as National Historic Landmarks or those listed on the National Register of Historic Places is included in the report subtotal for Heritage Assets and Stewardship Land. This change will identify MAPR assets so associated accrued DM can be included in the subtotal for heritage assets as well. The DOE does not accrue DM on land.</p>
