SUBJECT: Facilities Information Management System (FIMS) Version 1.20 Release

Today, Tuesday, March 4, 2008 version 1.20 of the Facilities Information Management System (FIMS) was released. These enhancements address Change Request 07-03, 07-05 and 07-10 which are available for review on the FIMS website at http://b5.216.217.68/change_requests.htm. These enhancements are automatically available to you when you log into FIMS from your browser. The following system enhancements are included in this new release.

- At the Site level, the GSA Report widow was renamed to FRPP Report.
- The following data elements were removed from the identified FIMS windows:
 - Site Info Regulatory Agreement

- GSA Report (now FRPP Report) – GSA Control Number

Excess Indicator (Site)

- Area Info M&O Contractor
- Building Condition Design Use
- The size of the OSF <u>Primary Quantity</u> and <u>Secondary Quantity</u> and the Archive -<u>Measurement</u> and <u>Secondary Quantity</u> data elements has been modified to include 3 decimal places. This allows FIMS to be consistent with FRPP reporting.
