SUBJECT: Facilities Information Management System (FIMS) Version 1.23 Release

Today, Thursday, October 9, 2008, version 1.23 of the Facilities Information Management System (FIMS) was released. This release addresses the enhancements on Change Request 08-04 which is available on the FIMS website at http://fimsinfo.doe.gov/change_requests.htm and various other enhancements as outlined below. These enhancements are automatically available to you when you log into FIMS from your browser.

- The ability to page from record to record has been added to the FIMS asset level processing. **Back** and **Next** buttons have been placed on the bottom left hand corner of the screen under the window navigation buttons (Property Info, Property Detail, Notes, ...). A message will be displayed if you are at the beginning or end of the current record list. Remember, you must use the **Save** button to save changes to the database prior to navigating to another record.
- The Summary/Detail Indicator has been removed from the Trailer Property Info window. This data field has also been removed from the following two reports:
 - 050 Trailers – Owned Complete Information Report
 - 052 Trailers – Leased Complete Information Report
- The 15 Sustainability data elements have been added to the Archive table. These values will be stored when DOE Owned building records are archived. The following two reports have also been modified to display the Sustainability data elements:
 - 079 Archive – Building/Trailer Report has been modified to display all 15 Sustainability data elements on the Excel format and to display the 15% Goal Flag and Assessment Status on the .pdf format.
 - 001 Buildings – Complete Information Report has been modified to display all 15 Sustainability data elements on the Excel format.
- A new standard report 005 Buildings – Sustainability Candidate Report has been developed. This new report will provide the Sustainability status for DOE owned buildings and will also include the Sustainability Index for square feet and building count. This report may be generated by Program Office and/or Site.

- The Using Organization picklist on the Property Detail window has been modified to display the code value along with the text description.

- The following 2 new standard reports have been developed for the FIMS OSF Validation process and are found on the Special report menu:
 - Report 070c – Random OSF Generator (FRPC Data Validation)
 - Report 070d – FRPC OSF Data Element Report

- The FIMS informational website (http://fimsinfo.doe.gov/data_validation.htm) now includes an OSF Auto Populate Data Validation Reporting form and an OSF Scorecard form. These forms can be located under the Data Validation page and contain all of the same functionality as the ones used for buildings and real property trailers.

- The FIMSWEB092308.MDB ad-hoc query database has been updated to reflect the changes to the `fims_tbl_archive` table. You can download the updated database from the FIMS website at <http://fimsinfo.doe.gov/downloads.htm>.

- The FIMS User's Guide, FIMS Reporting Guide, and FIMS Data Element Dictionary have been updated to reflect all of the above changes. These documents are available from the FIMS website at <http://fimsinfo.doe.gov/documentation.htm>.
