Today, Wednesday, February 28, 2018, version 3.5 of the Facilities Information Management System (FIMS) was released. This release addresses the enhancements listed below. Change Requests can be found on the FIMS informational website at <https://fims.doe.gov/fimsinfo/cr.html>.

CHANGE REQUEST 17-18

- **Core Capability - 1** has been added to the AAIM module and AAIM Report. It will transfer to FIMS when the AAIM asset is transferred if no previous value for Core Capability – 1 exists.

CHANGE REQUEST 17-19

- **Activity Type** has been added as a display only data field that identifies the approach and funding source for acquisition of real property. Activity Type is entered in the AAIM module and transferred to FIMS when the AAIM asset is transferred to FIMS.
- **Activity Type** has been added to the Ad Hoc Report – Active, Archived and Historical tools.
- **Activity Type** has been added to the AAIM Report.

CHANGE REQUEST 17-28

- **Disposition Fiscal Year** has been added to the Ad Hoc Report – Archive tool. It represents the fiscal year of the Disposition Date.

NBI STRUCTURE NUMBER

- **NBI Structure Number** is now display only. It is only to be used for OSF with Usage Code 1768, Public Access Bridge (Vehicular) that are identified in the National Bridge Inventory (NBI). Once established, this number should not be changed. Contact the FIMS Help Desk for any assistance needed with this data field.

USER'S GUIDE APPENDIX C – OSF USAGE CODES

- **1168 Public Access Bridge (Walking)** has been updated to include elevated walkways and pedestrian footbridges (enclosed or not) that connect buildings.
- **1169 Controlled Access Bridge (Walking)** has been updated to include elevated walkways and pedestrian footbridges (enclosed or not) that connect buildings.
- **2007 Smoking Kiosk** has been updated to include bus stops and is defined as

- **2007 Smoking Kiosk / Bus Stop** (Primary Unit of Measure = Each)
A small steel or aluminum structure having one or more open sides. A Smoking Kiosk is used by personnel for smoking outdoors. A Bus Stop is used by personnel as a loading/waiting/unloading zone for transportation services.

USER'S GUIDE APPENDIX A – DATA ELEMENT DICTIONARY

- The following was added to the **RPV – Buildings and Trailers** definitions.
 - Contractor generated RPVs must be regenerated every five (5) years. In years when the estimate is not regenerated, inflate the estimate to current year dollars.
