

CHANGE REQUEST 18-01

- **Estimated Disposition Year** is now required for all DOE Owned buildings, trailers, OSFs and land. The deadline for populating this data element for DOE Owned assets is **November 5, 2018**.
- For existing assets that have a **Status** other than In-Situ Closed or In-Situ Closed LTM and a current value of '9999' in the **Estimated Disposition Year**, the value for **Estimated Disposition Year** has been converted

to '8888'. Only assets with a **Status** of In-Situ Closed and In-Situ Closed – LTM can have a value of '9999' for the **Estimated Disposition Year**.

- The **Anticipated Disposition Method** will not be required to be populated if the **Estimated Disposition Year** contains a value of '8888' or '9999'.
- Reference the revised definition of Estimated Disposition Year in the FIMS User's Guide, Appendix A, Data Element Dictionary.

CHANGE REQUEST 18-07

- Asset Utilization Level now displays one of the following values based on the input of Asset % Utilized.
 - Unutilized Asset % Utilized < 1%
 - Underutilized Asset % Utilized between 1% to 39%
 - Utilized Asset % Utilized > 39%
- Reference the revised definition of **Asset Utilization Level** in the FIMS User's Guide, Appendix A, Data Element Dictionary.

FUNCTIONALITY ASSESSMENT DATE

• **Functionality Assessment Date** is now only required when the **Status** is set to Operating, Standby, or Outgranted. The field is disabled for assets with any other Status.

FIELD OFFICE COLLOCATION

- A new data element called **Field Office Collocation** has been added to the Property Info window. This field is required for all DOE Owned and DOE Leased buildings and trailers with a Usage Code of 101 (Office). The field is disabled for assets with any other Usage Code.
- This data element should be populated with a value of 'Yes' if the asset has office space that could be shared with other federal agencies. If not, a value of 'No' along with the reason would be selected from the pick list.
- This data element has been initially populated with a value of 'No Utilization' except for 8 assets that were received from Gordon Clark, Office of Asset Management, as part of a data call. Newly added office assets will also default to 'No Utilization'.
- The full definition for this new data element can be found in the FIMS User's Guide, Appendix A, Data Element Dictionary.

STATUS

 Can't Currently Be Disposed is now required to be populated once the Status is changed to In-Situ Closed or In-Situ Closed - LTM.

• The definition for **Disposition Method** has been revised to distinguish which options are used for DOE/GSA disposals and those that are used for GSA disposals only.
