Today, Tuesday, December 21, 2022, version 3.24 of the Facilities Information Management System (FIMS) was released. This release addresses the enhancements listed below.

### Life Cycle Cost Estimating

Life Cycle Cost estimating has now been incorporated into FIMS. This will provide preventive maintenance, maintenance & repair and replacement Life Cycle cost for building and trailers assets that have a **Replacement Plant Value (RPV)** based on a model. Life Cycle cost offers many benefits which include identifying maintenance and repair activities needed to keep facilities in good working order, help to eliminate a backlog of repairs and can also be beneficial for the planning/budgeting of facility preventive, maintenance & repair, and replacement costs.

- A Life Cycle cost estimating icon will now display on the O&M/Condition window adjacent to the **Annual Required Maintenance** for any building/trailer asset that has a FIMS generated **RPV** value. Upon clicking this button, a Life Cycle spreadsheet will be produced that includes both a detailed and summary sheet.
  - The detailed sheet of the Life Cycle Cost will include asset and model information, model assembly list which includes preventive, maintenance & repair, and replacement cost as well as Life Cycle cost projections for 50 years.
  - The summary sheet will summarize the Life Cycle cost by year and will also include indexed cost based on a user entered inflation percentage. The default inflation percentage is 3.5% but the value can be updated and the costs on this sheet will be automatically recalculated.

### Annual Required Maintenance

- Life Cycle cost will be used to generate **Annual Required Maintenance** in FIMS on February 17, 2022. This would apply to assets that have a FIMS and CAIS generated **RPV** value that is based on a model where the **Annual Required Maintenance** is found to be blank on February 17. Sites will have the option to override the FIMS generated value if they wish to do so. For assets where the **Annual Required Maintenance** has already been populated, FIMS will not override that value. The deadline for populating **Annual Required Maintenance** is March 31, 2022.
